#### 4. Approve Previous Meeting Minutes

a) October 11, 2022, Budget/Board Meeting

MOTION: JB/DB to approve the minutes of October 11, 2022, as printed and circulated. Motion Carried 7-0

# **5.** Unfinished Business from Previous Meetings for Consideration or Action None

#### 6. New Business for Consideration or Action

a) Purchase of Playground Equipment for Farmer's Field and Funding Options

MOTION: SH/MVH to purchase playground equipment for Farmers Field using the GAmeTime Grant (\$92,936.50) and \$129,614.11 in ARPA funds to purchase the equipment and using approximately \$75,000 in ARPA funds for installation costs.

Motion Carried 7-0

b) Authorizing Fire Chief to Purchase a Command Vehicle

MOTION: JB/DB to authorize the fire chief to purchase a command vehicle using reserve funds, not to exceed \$65,000.

Motion Carried 7-0

c) Reallocating 2022 Fire Department Capital Expenditure Funds from the Purchase of a Polaris Ranger UTV to the Purchase of a Digital Vehicular Repeater System. (DVRS)

MOTION: ML/DB to amend the 2022 budget by reallocating \$30,000 from the 2022 Fire Department Capital Expenditure Funds designated for the purchase of a Polaris Ranger UTV and move those funds to the purchase of a Digital Vehicular Repeater System.

Motion Carried 7-0

d) Employee HSA benefits

MOTION: SH/MVH to set the Village contribution to an employee's HSA account to be equal to the employee's 2023 health care deductible.

Motion Failed 2-5 (Blackmer, Baldwin, Brantmeier, Bartlein, and Lancaster opposed)

(Record to show that the employee benefits will remain the same as 2022. Staff is further directed to begin researching insurance options earlier in 2023 for board review prior to beginning 2024 budget discussions.)

#### e) Addition of DPW Staff

MOTION: ML/MVH to authorize the hiring of two additional seasonal positions in the summer at a pay scale of \$18 - \$20 / hour and in the winter at a pay scale of \$20 - \$22 / hour. Motion Carried 6-1 (Baldwin opposed)

(Record to show that the discussion's understanding is if there is difficulty in hiring the additional seasonal staff, then the Board will reconsider the request for an additional full-time employee.)
