6. Click on the **"2023"** located next to the "Print tax bills".
7. This will open a pdf of your 2023 tax bill.
 - a. The parcel number is located near the top, below the owner's name.
 - b. Your payment amount options are shown in the payment stubs at the bottom of the bill. Your 1st Installment amount is printed in the left stub's top right corner, your Full payment amount is printed in the right stub's top right corner. (The middle stub is for those that make a 2nd installment to the County in July.)
